This document must be returned completed, signed and accompanied by the requested supporting documents, otherwise it cannot be processed.

It is reminded that the holder of the securities account may, by proxy, authorize a person to operate the securities account. This power of attorney takes effect as of its receipt by Air Liquide and subject to the proxy holder's proof of signature and identity.

This power of attorney remains valid until its revocation by registered letter with acknowledgement of receipt to the Shareholder Services Department. It automatically ceases upon the death of the holder. Any change in the identity of the proxy holder and/or in the scope, duration or conditions of his/her powers of attorney requires the holder to update the proxy by contacting the Shareholder Services Department by registered letter with acknowledgement of receipt. The holder of the securities account shall refrain from contesting any transaction carried out at the initiative of his proxy.

In the case of a joint-ownership or split securities account, the designated representative represents only the account holder who has given him/her power of attorney. He/she has no power over the securities account unless designated as the principal by all the other joint holders.
